Online Applications (admission forms) are invited from the interested candidates for undergoing training in this Institute for the session 2023-24-25. The last date for applying **ONLINE** for admission has been extended to **6<sup>TH</sup> July 2023**. The candidate after finalizing the profile and application ONLINE will be required to deposit the printout of the system generated application form in ITI Bhallessa along with uploaded-self attested photocopies of below documents. However, the Last date for submission of Hardcopy at ITI is **6<sup>th</sup> July 2023**.

- Marks Certificate of qualifying Examination.
- Date of Birth Certificate.
- Category Certificate (SC/ST/Ex-servicemen/Physically handicapped/EWS) if any.
- Aadhaar Card.
- However, Domicile certificate should be produced at the time of admission.

**APPLYING ONLINE:-**


1. Aspirants need to carry admission activity via portal <http://itiadmissions.jkdspd.org>.
2. The candidate should use a valid Mobile No to register.
3. The candidate needs to fill/upload complete details as **personal profile**, which includes Photo, name, Parentage, address, qualification details, email ID.
4. Thereafter, candidate needs to complete online **applications form**.

**IMPORTANT NOTE:-**

- The candidate will be required to deposit the application fee **Rs.100/-** (one hundred) per three trades in the Accounts Section of ITI Bhallessa.
- Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination ( both for free and self financing seats separately )
- Candidates who have already undergone training in any of the trades in any ITI can apply for admissions in another trade after two years after completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
- **Minimum age** for the applicant is **14 years**, with no upper age bar (except Driver cum Mechanic LMV Trade for which Max. Age is 18 years).
- The detailed guidelines for filling the application forms by the candidates is also available on ITI admission portal.
