

The desirous candidates having minimum age of 14 year on 15 of September 2025 with no upper age bar.

However, Domicile certificate should be produced at the time of admission.


IMPORTANT NOTE:

- The candidate shall deposit the form fee @Rs. 100/= (One Hundred Only) per Three trades at Govt. ITI Kishtwar against
- Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination (both for free and self-financing seats separately).
- On successful completion of training in trades running under NCVT/SCVT Scheme, certificate will be awarded by National /
- Candidates who have already undergone training in any of the trades in any ITI can apply for admissions in another trade after two years after completion of previous training course. However, for the ensuing academic session, their admission
- Candidates should have unique mobile Number and e-mail address and to maintain it till completion of course and receive the certificate, as change is not permitted later.
